## Dean's Decree 2/2017

### Financial conditions of Advanced Master's State Examination in the English study programme "Pharmacy" at the Faculty of Pharmacy, UVPS Brno

The Decree is issued in accordance with § 46 para. 5 of the law 111/1998, as amended on the basis of § 13 of the Advanced Master's State Examination Provisions of the Faculty of Pharmacy, UVPS Brno.

The amount of the fee is determined by the relationship of the applicant to the Faculty of Pharmacy UVPS Brno and the method of implementation of the Advanced Master's State Examination.

All applicants will pay a fixed part of the fee EUR 80 for administrative work and the issue of the diploma, the variable part is determined by the method of implementation of the Advanced Master's State Thesis and Examination.

For the purpose of calculating the fee for the Advanced Master's State Examination process, candidates are divided into three groups:

#### 1<sup>st</sup> Group of Applicants includes:

- a) Members of academic staff of the Faculty of Pharmacy UVPS Brno
- b) Students of the English postgraduate study programme Pharmacy.

These candidates pay only a fixed part of the fee EUR 80 for administrative work and the issue of the diploma.

#### 2<sup>nd</sup> Group of Applicants includes:

Candidates who are not members of the 1<sup>st</sup> group and who will be given the access to information technologies of the Faculty of Pharmacy UVPS Brno without the rights to use the University facilities (laboratories and equipment).

For their Advanced Master's State Examination management, these candidates will pay the total amount of EUR 1 600, which includes a fixed part of the fee EUR 80 for administrative work and the issue of the diploma and the amount EUR 1 520 for allowing the access to information technologies of the Faculty of Pharmacy UVPS Brno and the access to consultations with the internal supervisor.

#### 3<sup>rd</sup> Group of Applicants includes:

Candidates who are not members of the 1<sup>st</sup> group and who will be given the access to information technologies of the Faculty of Pharmacy UVPS Brno together with the rights to use the University facilities (laboratories and equipment).

These candidates will pay for their Advanced Master's State Examination management the total amount EUR 2 000, which includes a fixed part of the fee EUR 80 for administrative work and the issue of the diploma, the amount of EUR 1 520 for allowing the access to information technologies of the Faculty of Pharmacy UVPS Brno and the access to consultations with the internal supervisor and the extra amount of EUR 400 which gives them the right to use University facilities (laboratories and equipment including consumables).

For the first reparatory term of the Advanced Master's Examination or its part, there is the set fee EUR 60. For the second reparatory term of the Advanced Master's Examination or its part, the fee is set to EUR 120.

Acceptance of applications, their assessment and evaluation of the Advanced Master's State Examination is included in the educational activities of the University in accordance with Act No. 111/1998 Coll. as amended, and related regulations. By issuing Dean's Decree No. 2/2017 expires Dean's Decree No. 1/2016 dated April 10<sup>th</sup> 2016.
